### CLAUSE 3) OFFICE OF THE TRUST

The Principal office of the Trust shall be for the time being at F4, Balaji Apartments, A.R.B.Gardens, No.25, Vengan Street, Chidambaram 605 001. The Trust shall have activities throughout our country and shall establish office(s) or location(s) Educational Institution(s) at such other place or places with in India as the Trust Board decides to do so. If the Chairman & Managing Trustee / Director feels that the principal office of the trust is to be shifted to some other place for carrying out and furthering the objectives of the Trust more efficiently and economically then the principal office of the Trust shall be at such other place as deemed fit.

#### CLAUSE 4) AIMS & OBJECTS OF THE TRUST

The Trust has been constituted for and shall carry out all or any of the following objects for the welfare of the general public irrespective of caste, colour, creed, sex or religion:

- a) To help for the advancement of education amongst the needy public by granting scholarship, educational loan or any assistance to deserving students studying in any type of educational institution.
- b) To render medical assistance to needy students by way of reimbursement of medical expense, purchase of medicine, medical bills either fully or partly.
- c) To establish and run any Educational institutions, schools/colleges/institutions of any kind, including Education, Law, Engineering, Medicine/Paramedicine in imparting professional education, other colleges of Arts, Science, Education/ Teacher Education/ Computer Education/ Training Music, Fine Arts, Technology, I.T.I., Polytechnic, and any other institution for imparting any type of education including Community colleges, Deemed Universities / Universities or any type of institution defined by the Government from time to time for the benefit of the society or students.
- d) To establish or acquire and manage existing educational institutions, colleges, schools, Institutes, hostels, home for adults or disabled persons or widows, orphans, physically challenged persons etc.
- e) To aid establishments and all types of educational institutions for the benefit of the public at large, provide consultancy services in the field of education and for running of such institutions for the cause of furthering education amongst the public at large.

- f) To run institutions for non-formal, social, adult and mass education, correspondence education and such other modes of education as are deemed fit to serve the cause of advancement of education and promotion of literacy amongst the public at large.
- g) To run hostels for the benefit of students and youths and homes for abandoned aged people, disabled persons and abandoned children, working women etc.
- h) To publish circular letters, periodicals, books, journals, newspapers, bulletins, leaflets and newsletters, etc., devoted to the promotion or furtherance of the cause of education and culture.
- i) To assist any institution formed for the advancement of education or culture and which is recognized as an activity of a Public Trust.
- j) To do or cause to be done all such lawful things as are in accordance with the spirit and principles of the objects of the trust (or) which is reconstructive to the attainment and pursuit of the aim and objects of the Trust.
- k) To provide Guidance and Counseling for the benefit of students and unemployed youth.
- l) To organize, arrange and promote suitable activities for the welfare and development of the society and community.
- m) It is further declared that this Trust shall exist solely for educational, social and charity purposes and not for purposes of profit.
- n) Each of the above objects shall be independent of the other and none of the above objects shall involve the carrying on of any business, trade or any activity for profits.
- o) It is further declared that the trust shall not carry on any business, trading activity or activities for profit. The aforesaid objects shall be

provided to the beneficiaries without discrimination of caste, creed, colour, sex or religion.

- p) Any activity of the Trust shall be treated as Trust performance and the accounts there on will be brought into the Trust account

#### CLAUSE 5) TRUST FUND

- a) A Sum of Rs.1,001/- (Rupees one thousand and one only) declared by the Author and Founder of the Trust forms part of the corpus of the Trust.
- b) The proceeds of donations / grants or any financial assistance received from the public shall be credited to the Trust fund. The Trust will not accept any donations/grants or any financial assistance of foreign contributions.
- c) The income of the properties of the Trust to be purchased and sale proceeds of any property of the trust sold and income from the permitted activity if any, shall be credited to the Trust fund.
- d) The Trust shall invest in such manner as would comply with the various enactments governing investment of funds by educational institutions.

#### CLAUSE 6) MANAGEMENT OF THE TRUST

- a) The Author and Founder of the Trust Thiru. C.R. Lakshmikandhan shall be the CHAIRMAN AND MANAGING TRUSTEE / MANAGING DIRECTOR during his life time and he will not be removable in any case.
- b) In the event of the demise of C.R. Lakshmikandhan, Chairman & Managing Trustee / Managing Director or expressing inability to manage the Trust in writing, L Anisha Manjeni shall be the Chairman and Managing Trustee / Managing Director for her life time and will not be removable in any case.
- c) After the lifetern of L. Anisha Manjeni or in the event of expressing her inability to manage the Trust in writing L. Akila shall be the life time Managing Trustee / Director who will not be removable in any case.

- d) L Akila shall nominate the Chairman & Managing Trustee / Director , to become her successor after her lifeterm, by will. In the absence of such a will the eldest member in the lineal descendants of L Anisha Manjeri or L Akila shall be the life term Chairman and Managing Trustee / Director .
- e) The strength of the Board of Trustee / Directors including Chairman and Managing Trustee / Director at any time shall be not more than FIVE.
- g. The Author of the Trust may appoint other Trustee / Director or Trustees / Directors including life term Trustee / Director, but the total strength of the Board of Trustee / Director shall not exceed FIVE including the Chairman & Managing Trustee / Director .
- h. The Chairman & Managing Trustee / Director shall always have the right to appoint, Trustee / Director or Trustees / Directors including Life time Trustees / Director (s) without the consent of the other Trustees / Directors.
- i. The Author of the Trust shall be the Chairman and Managing Trustee / Director and shall preside over the meetings of Board of Trustees / Directors. The Chairman and Managing Trustee / Director shall have a casting vote in case of equality of votes amongst Trustee / Directors.
- j. The Chairman and Managing Trustee / Director may appoint Secretary and Treasurer if necessary among the Trustees / Directors or from persons other than Trustee / Directors who will be special invitees to the Trust Board meeting without voting power.
- k. Any Trustee / Director other than the Chairman and Managing Trustee / Director and Lifeterm Trustees / Directors may be removed from the office of the Trust either by a resolution of the Board of Trustees /

Directors passed by a 2/3<sup>rd</sup> majority or by the Chairman and Managing Trustee / Director / himself / herself.

- 1) On being found guilty of misconduct, breach of trust, or activities prejudicial to the interests of the trust.
- 2) On being convicted in any criminal offence and sentenced by a Court of Competent jurisdiction.
- 3) On declared insolvent; and
- 4) If any Trustee / Director becomes permanently sick and bed ridden not being able to attend to the affairs of the trust or suffers from a permanent sickness or a personal disability which renders him/ her incapable of attending to the affairs of the Board of Trustee/s Director/s;
- 5) Any Trustee / Director retiring, resigning or being removed from office shall continue to be liable to the Trust for all the acts during the period for which he / she was a Trustee / Director.

**CLAUSE 7) PROCEEDINGS OF THE TRUST**

- a. The Board of Trustees/ Directors shall meet at least once a year with a clear notice of seven days by the Chairman & Managing Trustee / Director of the Trust.
- b. The Chairman and Managing Trustee / Director shall preside over all the board meetings of the Trust.
- c. If for any reason, he/she could not attend the meeting and informs it in writing, the Trustees / Directors present shall elect one amongst them to preside over that meeting or a senior most Trustee by age will preside over the meeting. The Trustee / Directors may meet together for the despatch of day to day work, adjourn otherwise regulate their proceedings as they may, from time to time, think fit.

- d. The resolution in writing signed by the majority of the Trustees / Directors by circulation shall be as valid and effectual as if it had been passed at the meeting of the Trustees / Directors duly called and constituted.
- e. The quorum for holding the Trustees / Directors meeting shall be two including the Chairman & Managing Trustee / Director.
- f. The decisions taken by the majority of the Trustee / Directors shall be valid and effectual and shall be carried out. However the Chairman and Managing Trustee / Director has the inherent power to veto any such decision in the interest of the Trust and its objects.

**CLAUSE 8) POWERS AND DUTIES OF THE CHAIRMAN AND MANAGING TRUSTEE / DIRECTOR**

The Chairman and Managing Trustee / Director shall have full discretion in the matter of administration, appointments, maintenance and management of the trust and its properties now existing and acquired hereafter, and shall have the power of day to day management of the trust and the following powers shall also be vested with the Chairman and Managing Trustee / Director.

- a. To appoint all kinds of employees of the Trust and institutions sponsored by the Trust and take disciplinary action against them including suspension and termination of service etc.,
- b. To appoint Correspondents/ Secretaries, Various Committees required and Committee members and Legal / Audit advisors, wherever and whenever necessary to educational institutions to be started by the Trust and to make changes in such appointments or bodies as and when required.
- c. To employ agents, bankers, brokers, lawyers, accountants, advisors and others at such remuneration as he thinks fit.

- d. To appoint administration Committees or Councils for Trust educational institutions, Trust selection committee, advisory committee etc for institutions and to define their powers. The terms, conditions; rules and regulations for properly carrying out the objectives of the trust will be solely within the full discretion of the Chairman & Managing Trustee / Director and to suit the requirements and benefits of the trust from time to time.
- e. To revoke any decision of the trust if it is not beneficial or contrary to the objects of the Trust.
- f. To act, decide and function on behalf of the Trust with full powers in accordance to the provisions of the Trust and any such action of the Chairman & Managing Trustee / Director is final and treated as the decision of the Board.
- g. To sign all kinds of documents wherever necessary towards loan or advance obtained from any bank or financial institution any mortgage of assets of the Trust or Trust institutions or assets of his / her towards such loans from any bank or financial institutions. Such execution of documents by the Chairman and Managing Trustee / Director will be considered to have been done on behalf of the Trust.
- h. To buy / sell / mortgage, movable or immovable properties for the Trust and educational institutions to be started by the Trust.
- i. To form a logo for the Trust.
- j. To give different Title or Name / Logo to various educational institutions to be started by the Trust.
- k. To open, maintain, deposit and operate any kind of bank accounts in any kind of Bank in the name of the Trust and to make all accounts operated by the Managing Trustee / Director.

**CLAUSE 9) POWERS & DUTIES OF OTHER TRUSTEES / DIRECTORS:**

1. To entrust the trust funds and names in such securities and investments in accordance with legal provisions as maintained from time to time and as applicable to educational institutions and in particular in compliance with the provision of the Income Tax Act.
2. To buy or take on lease or rent immovable properties for the trust and or put up building or structures on land belonging to or under the control or possession of the trust.
3. To sell or otherwise dispose off any immovable property.
4. To let any portion of immovable property forming part of the trust fund at such rent and for such period and on such terms and conditions as they may think fit and to accept surrender of any lease.
5. To open, maintain, deposit and operate any kind of bank accounts in any kind of Bank in the name of the Trust and to make all accounts operated by the Managing Trustee / Director
6. To institute conduct, defend, compound or abandon any legal proceedings by or against the trust or Trustee / Director s, and allow time and indulgence for payment or satisfaction of any debt dues or any claim or demand by or against the trust. The trust shall be represented by the Managing Trustee / Director in all proceedings.
7. To delegate any power as they can lawfully delegate to any person and to execute such power of attorney as they may think fit for the purpose.
8. To withdraw any power or revoke any appointment of any employees or attorney.





9. To determine the name of the Trustee / Director as regards investments in share, stocks, debentures and other securities and other investments.
10. To raise funds by means of Donations, Deposits, Loans, etc and to borrow money for the purpose/ purposes of the Trust on such terms and conditions as may be agreed to by the Trustees / Directors and to authorize Chairman and Managing Trustee / Director to execute such documents including the deeds of mortgage, charge of hypothecation as may be necessary for the said purpose and also to create any mortgage or charge on any of the Trust properties movable or immovable for the said purpose.

**CLAUSE 10) REMUNERATION OF TRUSTEES / DIRECTORS & EMPLOYEES.**

1. The Trustees / Directors shall not be entitled to any remuneration for services rendered by them as Trustees / Directors of this Trust.
2. The Employees of the Trust or the Trust institutions are eligible for remuneration to be fixed either by the Chairman & Managing Trustee / Director or by any authorised person or persons of the Trust Institutions as the case may be.

**CLAUSE 11) ACCOUNTS**

The Trust shall maintain regular accounts of all its transactions showing clearly the receipts and expenditures.

All the expenses of the trust shall be properly vouched and audited by a Chartered Accountant every year. The Accounts of the Trust shall be approved by the Board of Trustees / Directors every year.

**CLAUSE 12) STATUTORY OBLIGATIONS :**

- a. The Trustees / Directors shall comply with all the relevant statutory obligations.
- b. The Trust shall invest the Trust funds in such forms and in such securities as are permitted by the law governing investment of funds by educational Institutions. No investment shall be made by the trust which shall render



it ineligible for exemption under provision of the Income Tax Act in respect of donations received by it or in respect of income earned by it.

**CLAUSE 13) INDEMNITY :**

The Trustees / Directors shall at all times stand indemnified in respect of any act they may have bonafide, committed or omitted to be done in respect of matters relating to the Trust.

**CLAUSE 14) GENERAL :**

- a. The Author of the Trust hereby declares that this declaration of Trust shall be irrevocable.
- b. The Author of the Trust hereby declares that the Trust shall be a Public Trust and shall always be a Public Trust on and from the date of its formation.
- c. The income from the Trust after meeting out the expenses shall always be used and applied for, for the furtherance of their objectives and purpose mentioned and specified herein above.
- d. The funds of the Trust shall not be distributed among or appropriated by the Trustees / Directors for their own benefit.
- e. It shall be the Endeavour of the Trust that the benefits and objectives of the trust shall be for the benefit of the public at large irrespective of sex, caste, creed and religion.
- f. The Trustees / Directors shall have the power and amend, modify or change the rules and regulations contained herein for the effective functioning of the Trust without affecting the basic character and object of the Trust. However, this shall be carried out by the approval of the Managing Trustee / Director and by the majority of the Trustee / Director s.





g. Any change in the trust deed made on its future date, will be carried out with the approval of the commissioner of Income Tax of concerned jurisdiction by law.

h. In case there is no son or daughter to any Chairman & Managing Trustee / Director, he/she shall have the power to nominate his / her successor by will.


**CLAUSE 15) WINDING UP :**
